ORDER EXTENDING DEADLINE TO FILE JOINT PROPOSED PROCEDURAL SCHEDULE

On April 12, 2024, the Commission issued its Order Directing Joint Proposed Procedural Schedule, directing its Staff to collaborate with the other parties and file the proposed procedural schedule no later than May 3, 2024.

On May 3, 2024, Staff filed a *Motion to Extend Procedural Schedule Deadline*. In the motion, Staff indicates that the case is settled, except for possibly one issue that may require a hearing. As the parties continue discussions on the unresolved issue, Staff requests a 31-day extension of the deadline to file a proposed procedural schedule.

The Commission finds the request reasonable and will grant the motion.

THE COMMISSION ORDERS THAT:

1. Staff's *Motion to Extend Procedural Schedule Deadline* is granted.
2. No later than June 3, 2024, Staff shall collaborate with the other parties and file a joint proposed procedural schedule on behalf of all parties.

3. This order shall be effective when issued.
