On May 2, 2024, The Empire District Electric Company d/b/a Liberty filed a variance request for the purpose of late filing its annual demand side program report pursuant to Commission Rule 20 CSR 4240-20.093(9). Liberty notes that it received a prior variance from the above Commission Rule for file its first annual report on May 1, 2023. In support of its position, Liberty states that it discovered a formulaic error that delayed its report submission.

Pursuant to Commission Rule 20 CSR 4240-20.093(9) interested parties will have 30 days from the actual submission date of Liberty's annual demand side program report to file comments with the Commission.

The Commission will set a deadline for any objections to Liberty's late filing variance request.
