On April 16, 2024, In File No. WC-2023-0353, the Commission granted Staff's request to continue the evidentiary hearing set for April 24, 2024, at least 30 days. Staff plead that it had been informed that Blevins had been hospitalized and could not attend the hearing. The Commission directed Staff to file a status report or alternative pleading by May 16, 2024.

On April 30, 2024, Staff filed a motion to reschedule the evidentiary hearing. Staff noted that little, if any, work has been done to repair distressed wells and new leaks and well failures continue to accumulate.

On May 7, 2024, Staff filed a status report in File No. WO-2024-0036 further explaining that Blevins has failed to correct deficiencies assessed by the Missouri

Department of Natural Resources. Further, that the owner of one of the wells has requested that Blevins disconnect his customers from their well.

The Commission will schedule a WebEx procedural conference to discuss how these matters will proceed.
