**ORDER EXTENDING DEADLINE TO FILE  
STAFF INVESTIGATIVE REPORT**

On August 10, 2023, the Commission issued an order establishing a case for purposes of receiving an investigative report from the Commission’s Safety Engineering Department regarding an incident on July 17, 2023, involving the release and ignition of natural gas in Springfield, Missouri in an area serviced by the municipal gas system of City Utilities of Springfield (CU). The Commission set a deadline for the Staff of the Commission (Staff) to file an investigative report regarding the incident or a status report. The deadline has subsequently been extended twice, most recently to May 10, 2024.

On May 7, 2024, Staff filed a *Status Report* in which it stated that it has still not received CU’s failure investigation. Consequently, Staff requested a further extension to file its investigative report, or a report on the status of the investigation.

The Commission will grant Staff’s request.

**THE COMMISSION ORDERS THAT:**

1. Staff shall file its report regarding the July 17, 2023, incident described in the body of this order – or a report on the status of its investigation – no later than July 19, 2024.
2. This order shall be effective when issued.

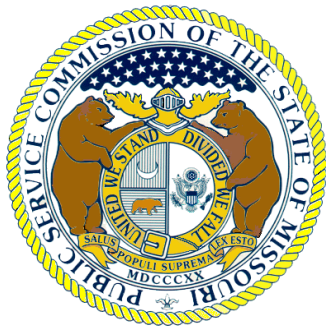
