On April 18, 2024, Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed an application requesting that the Commission approve the acquisition of the unregulated sewer assets of Barbara E. Rampone located in and around the Timber Ridge subdivision in Johnson County, MO (Timber Ridge System). The Timber Ridge System provides sewer services to five connections near the town of Knob Noster.

The Commission has issued notice of this application, and the Commission has received no requests to intervene. Thus, the Commission will order its Staff to file a Recommendation.

THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall file a Recommendation, or a status report stating when it expects to file its Recommendation, no later than June 11, 2024.
2. This order shall be effective when issued.
