- 1. On January 19, 2024, the Public Service Commission of the State of Missouri (the "Commission") issued its Order Setting Procedural Schedule. (Doc. 10).
- 2. The Order Setting Procedural Schedule identified May 13, 2024, as the deadline to file Statements of Position. (*Id.*).
- 3. "When an act is required or allowed to be done by order or rule of the commission at or within a specified time, the commission may—... [o]rder the period enlarged before the expiration of the period originally prescribed or as extended by a previous order." 20 CSR 4240-2.050(3)(A).
- 4. The deadline to file Statements of Position has not yet expired.
- 5. The Filing Parties, as well as the Staff of the Commission (the "Staff"), have been conducting settlement discussions and would like to continue those discussions.

- To allow time for additional settlement discussions, the Filing Parties request that
 the Commission extend the deadline to file Statements of Position four days, to
 May 17, 2024.
- 7. The Staff does not oppose this request.

WHEREFORE, the Filing Parties respectfully request that the Commission extend the time to file Statements of Position to May 17, 2024.
