ORDER PROVIDING NOTICE OF EXPIRATION OF VIDEO SERVICE AUTHORITY

Effective Date: May 25, 2024

On March 1, 2012, in File No. KA-2012-0280, the Commission, pursuant to Section 67.2679, RSMo (Cum. Supp. 2010), granted Google Fiber Missouri, LLC (the Company) authority to provide video service in the franchise area of the political subdivision of the City of Kansas City.

On May 13, 2024, the Company filed notice with the Commission that it has ceased providing video service and requests termination of its video service authorization.

Under Section 67.2685, RSMo 2016, the Company's video service authorization shall expire upon notice to the Commission that it will cease to provide video service under such authorization.

THE COMMISSION ORDERS THAT:

1. The Commission acknowledges receipt of notice by Google Fiber Missouri, LLC that it has ceased to provide video service authorized by the Commission in File No. KA-2012-0280. The authorization expires by operation of law and no further action by the Commission is required.
2. This order shall be effective on May 25, 2024.
3. This file shall be closed on May 26, 2024.
