**ORDER GRANTING ADDITIONAL TIME
TO FILE ANSWER TO COMPLAINT**

On April 16, 2024, the Staff of the Commission (Staff) filed a complaint against Spire Missouri Inc. d/b/a Spire alleging violation of certain sections of the Commission’s gas safety rules.

On April 23, 2024, the Commission issued a *Notice of Complaint and Order Directing Answer* in which Spire was directed to file an answer to the complaint no later than May 23, 2024.

On May 13, 2024, Spire filed a *Request for Additional Time to File an Answer or Status Update*, in which it asks for additional time to have discussions with Staff that would be beneficial to potentially reaching resolution of the complaint. Staff does not object to Spire’s request.

The Commission will grant Spire’s request.

THE COMMISSION ORDERS THAT:

1. Spire's request for additional time to file an answer to Staff's complaint is granted.
2. Spire shall file an answer to the complaint, or a status report, no later than June 24, 2024.
3. This order shall be effective when issued.
