## ORDER SETTING TIME FOR RESPONSES

On April 18, 2024, Liberty Utilities (Missouri Water), LLC d/b/a Liberty Utilities (Liberty) filed its 2024 five-year capital budget, and on April 19, 2024, Liberty filed its five-year capital plan for water and wastewater. There is no cover pleading attached to Liberty's filings, but the type of filing indicates that they are responses to the Commission's order. Commission Rule 20 CSR 4240-2.080(13) allows parties ten days to respond to any pleading, unless another response time is established by the Commission. No responses to Liberty's filings were received.

It does not appear any Commission action is required. Therefore, the Commission will set a deadline for any responses to Liberty's filings and, if none are received, then the Commission will close this file.

### THE COMMISSION ORDERS THAT:

1. Any responses to Liberty's April 18 and 19, 2024, filings in this case are due no later than May 22, 2024.
2. This order shall be effective when issued.

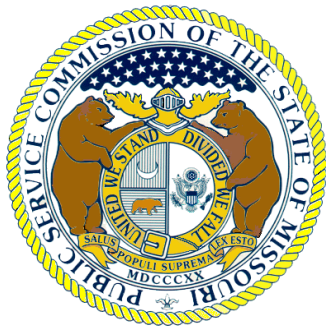
