**ORDER DIRECTING RECOMMENDATION ON
SATISFACTION OF CONDITION PRECEDENT TO GRANTING OF
CERTIFICATE OF CONVENIENCE AND NECESSITY**

On March 21, 2024, the Commission issued its *Order Approving Stipulation and Agreement and Granting Certificates of Convenience and Necessity* (Order). The Order granted a certificate of convenience and necessity (CCN) for three solar generation facilities requested by Union Electric Company d/b/a Ameren Missouri but deferred approval of a CCN for a 150 megawatt solar generation facility to be constructed in Cass County, Illinois (the “Cass County Project”) unless and until a condition precedent set out in the Stipulation and Agreement was satisfied.

On May 16, 2024, Ameren Missouri filed its *Notice that Condition Precedent to Issuance of CCN for the Cass County Project Has Been Satisfied and Request for CCN*, stating that the condition precedent has been satisfied and requesting the Commission to issue an order granting a CCN for the Cass County Project by June 19, 2024.

The Commission will direct its Staff to file a recommendation as to whether the condition precedent set out in the Order has been satisfied and a CCN for the Cass County Project should be granted by the Commission.

THE COMMISSION ORDERS THAT:

1. No later than May 30, 2024, Staff shall file a recommendation as to whether the condition precedent set out in the Order has been satisfied and a CCN for the Cass County Project should be granted by the Commission to Ameren Missouri.
2. Any party wishing to respond to Staff's recommendation shall do so no later than June 6, 2024.
3. This order shall be effective when issued.
