**ORDER RESETTING EVIDENTIARY HEARING**

The Commission set an evidentiary hearing for April 24 and 25 of 2024. That hearing was canceled due to Respondent’s hospitalization. On May 16, 2024, the Commission held a procedural conference to determine how to proceed with this complaint. The Commission will reschedule the evidentiary hearing based upon dates discussed at the procedural conference.

The ownership of the various wells in the three systems that Blevins operates is unclear even after the related receivership hearing in File No. WO-2024-0036. Therefore, the Commission is making the ownership of the wells and the composition of the water systems an issue Staff must address that issue as part of this complaint.

**THE COMMISSION ORDERS THAT:**

1. An evidentiary hearing is scheduled for June 24 and 25 of 2024, beginning at 9:00 a.m. The hearing will be held in Room 310 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. The hearing will be held in a building that
