On April 29, 2024, the Commission directed its Staff to consult with the parties in this matter and file proposed dates and locations for a local public hearing. On May 7, 2024, Staff filed a response that proposed a local public hearing take place on May 29, 2024, at 6:00 p.m. On May 16, 2024, the Commission issued an *Order Regarding Scheduling of Local Public Hearing*, directing Staff to consult with the other parties and file an alternative hearing date.

On May 20, 2024, Staff filed its Suggested Local Public Hearing Dates.

The Commission will now set the local public hearing date, time, and location.

THE COMMISSION ORDERS THAT:

1. A public hearing is scheduled for 6:00 p.m. on Monday, June 3, 2024. The hearing will take place at St. John the Baptist School, 5579 Gildehaus Road, Villa Ridge, Missouri. The public hearing will begin with a question-and-answer session and formal public comments to the Commission will begin immediately following the conclusion of the question-and-answer session.

2. No later than ten days before the local public hearing, TBJ Sewer Systems, Inc. shall provide notice of the public hearing to each of its customers, and shall

file a status report with the Commission detailing the notice, and how and when it was delivered.

3. The Commission's Public Policy and Outreach Department shall make an informal presentation and conduct a question-and-answer session for the public at the beginning of the local public hearing.

5. Comments may be submitted to the Commission in writing by mailing the comment to the Missouri Public Service Commission, P.O.
