ORDER DIRECTING EXPEDITED STAFF RECOMMENDATION ON REVISED TARIFF SHEET AND SETTING TIME FOR RESPONSES

On May 21, 2024, Spire Missouri Inc. d/b/a Spire filed a revised tariff sheet to reflect changes in its Purchased Gas Adjustment (PGA) rates for its western Missouri operating division. The tariff sheet bears an effective date of June 5, 2024.

The Commission will direct the Staff of the Commission (Staff) to file an expedited recommendation on the tariff sheet. The Commission will also establish a deadline for any responses to the tariff sheet filing and Staff's recommendation.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation concerning the above-referenced tariff sheet no later than May 30, 2024.
2. Any other responses concerning Spire's tariff sheet or Staff's recommendation shall be filed no later than May 31, 2024.
3. This order shall be effective when issued.
