**ORDER SETTING A DEADLINE FOR EXHIBITS, OBJECTIONS, AND
DIRECTING THE FILING OF POST-HEARING BRIEFS**

During the evidentiary hearing in the above captioned matter, the Regulatory Law Judge directed that any unsubmitted exhibits be filed after the hearing.

The Commission set May 24, 2024, for the submission of further exhibits, and also set May 30, 2024, as the deadline for objections.

In the procedural schedule issued by the Commission on February 28, 2024, *optional* post-hearing briefs were to be filed by June 10, 2024. Because post-hearing briefs will assist the Commission in determining this complaint, the Commission will direct its Staff and Ameren Missouri to file post-briefs no later than June 10, 2024.

THE COMMISSION ORDERS THAT:

1. Any further exhibits shall be filed no later than May 24, 2024.
2. Objections to those exhibits shall be filed no later than May 30, 2024.

3. The Staff of the Commission and Ameren Missouri shall file post-hearing briefs no later than June 10, 2024.

4. This order shall be effective when issued.
