**ORDER DIRECTING NOTICE, ESTABLISHING TIME FOR FILING
REQUESTS TO INTERVENE AND ESTABLISHING
TIME FOR FILING RECOMMENDATIONS**

This order directs that notice of this case be sent to all certificated interexchange and basic local exchange telecommunications companies in the state of Missouri and to the North American Numbering Plan Administrator. The order also establishes dates for the filing of requests to intervene and for the filing of recommendations.

On May 21, 2024, MCIMetro Access Transmission Services Corp d/b/a Verizon Access Transmission Services, filed an application and Motion for Expedited Treatment under 47 C.F.R. 52.15(g)(3)(iv) requesting that the Commission review and reverse a decision of the North American Numbering Plan Administrator to withhold certain numbering resources from Verizon Access. The numbering resources Verizon Access requested consist of ten thousand-blocks of numbers in the Cape Girardeau, Missouri rate center. The numbering resources are needed in order to meet the needs of Mercy Medical Group for a continuous range of 1,000 contiguous direct inward dialing (DID) numbers to implement new phone service to improve patient medical services with new technology.

The Commission finds that proper persons should be allowed to file a request for intervention or a motion for hearing. Therefore, the Commission will set a time for interventions as directed below. The Commission will also direct its Data Center to send a copy of this order to each certificated interexchange and basic local exchange telecommunications company in Missouri. In addition, the Data Center shall send a copy of this order to the North American Numbering Plan Administrator.

The Commission will also direct its Staff to file a recommendation and will establish a date by which any other party wishing to respond must file a recommendation.

IT IS ORDERED THAT:

1. The Data Center shall send a copy of this order to each certificated interexchange and basic local exchange telecommunications company in Missouri and to the North American Numbering Plan Administrator.

2. Applications for intervention shall be filed no later than May 28, 2024.

3. The Staff of the Commission shall file a recommendation regarding the application of Verizon Access or shall file a status report indicating when a recommendation will be filed, no later than May 28, 2024.

4. Any other party that wishes to file a recommendation regarding the application of Verizon Access, shall do so no later than May 28, 2024, and shall file its recommendation simultaneously with its application to intervene.

5. This order shall become effective May 22, 2024.

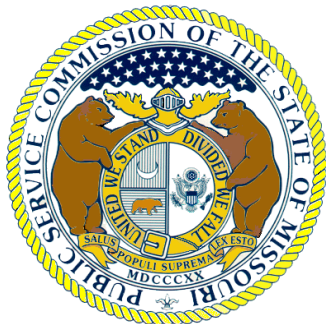
