STAFF'S STATUS UPDATE

COMES NOW the Staff of the Missouri Public Service Commission, by and through counsel, and for its *Status Update* respectfully states as follows:

- 1. On June 13, 2016, Staff filed its *Report of First MEEIA Prudence Audit* ("Report") which covers MEEIA Cycle 1 costs through December 31, 2015, but excludes Cycle 1 carry-over costs incurred in 2016. The Report states on page 15 Staff's intent to conduct a separate prudence review of Cycle 1 carry-over costs in the fall of 2016.
- 2. The Commission approved the Report on August 10, 2016, but it did not specifically mention a separate prudence review of Cycle 1 carry-over costs.
- 3. The second KCPL MEEIA prudence review has not yet been scheduled, but it must begin no later than early January 2018.
- 4. The Energy Resources Department currently has a high workload. Accordingly, Staff would be hard-pressed to complete this Cycle 1 carry-over costs prudence review during the fall of 2016.

¹ The Report indicates that even though this current MEEIA prudence review is for the 18 months ending December 31, 2015, these carry-over costs represent costs associated with large commercial projects that were planned and approved during the Review Period but will not be completed until sometime in the January – June 2016 time period with final rebates paid to customers up to July 31, 2016.

5. The prudence review of Cycle 1 carry-over costs can be completed sometime in 2017 or early 2018 when Staff performs its second KCPL MEEIA prudence review. Such a timeframe would result in no harm to ratepayers and would allow Staff to conduct a more thorough review.

WHEREFORE, Staff respectfully requests the Commission accept its *Status*Report and allow Staff to complete the prudence review of carry-over costs during the second KCPL MEEIA prudence review.
