ORDER GRANTING EXTENSION TO FILE RESPONSE

On April 15, 2016, Union Electric Company, d/b/a Ameren Missouri filed its 2015 Renewable Energy Standard Compliance Report and 2016-2018 Renewable Energy Standard Compliance Plan, as required by Commission Rule 4 CSR 240-20.100(8). The Commission's Staff, Earth Island Institute, d/b/a Renew Missouri, and United For Missouri, Inc., filed responses to Ameren Missouri's 2016-2018 Plan on May 27, 2016. Staff filed its response to Ameren Missouri's 2015 RES Compliance Report on June 24, and the Division of Energy responded to Renew Missouri's comments on the same date. On June 27, the Commission ordered that any person or entity wishing to respond to Staff's reports, or to the various comments, do so by July 8.

On July 5, Ameren Missouri and the Division of Energy filed a motion asking that the Commission extend the time for response to July 29 to allow more time to discuss and possibly resolve Division of Energy's concerns about Ameren Missouri's modeling of the 1% retail rate impact limitation. That motion represents that the other entities that have filed comments have indicated they do not object to the granting of additional time to respond.

The Commission will grant the extension requested by Ameren Missouri and the Division of Energy.

THE COMMISSION ORDERS THAT:

1. Union Electric Company d/b/a Ameren Missouri's and the Division of Energy's Motion to Extend Time for Response is granted.

2. Any person or entity wishing to respond to Staff's Report on Ameren Missouri's 2015 Renewable Energy Standard Compliance Report, to Staff's Report on Ameren Missouri's 2016-2018 Renewable Energy Standard Compliance Plan, or to the Comments of Renew Missouri, United for Missouri, or Division of Energy, shall do so no later than July 29, 2016.

3. This order shall be effective when issued.
