On May 15, 2024, the Commission issued its *Order Approving Stipulation and Agreement and Establishing Ending ACA Balance* (Order). On May 23, 2024, Spire Missouri Inc. d/b/a Spire filed a revised tariff sheet, assigned Tracking No. JG-2024-0159, purporting to comply with the Order.

The Commission will direct its Staff to file a recommendation on the tariff sheet. The Commission will also establish a deadline for any responses to the tariff sheet filing and Staff's recommendation.
