**JOINT MOTION FOR SUSPENSION OF PROCEDURAL SCHEDULE**

**COME NOW**, Evergy Metro, Inc. d/b/a Evergy Missouri Metro (“Evergy Missouri Metro”) and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (“Evergy Missouri West”) (collectively, the “Company”), the Staff (“Staff”) for the Missouri Public Service Commission (“Commission”) and the Office of the Public Counsel (“OPC”) hereby file their *Joint Motion for Suspension of Procedural Schedule* (“Motion”).

1. On January 19, 2024, the Commission issued its *Order Setting Procedural Schedule* (“Order”) setting multiple deadlines as requested by the parties, including evidentiary hearings set for May 29-30, 2024.

2. The Company, Staff and OPC have continued their settlement discussions and reached an agreement in principle that would resolve all issues in the case. Therefore, the Company, Staff and OPC request that the Commission suspend the procedural schedule, pending the filing of a Stipulation and Agreement that would resolve all issues in the case.

WHEREFORE, the Company, Staff, and OPC respectfully submit this Motion for suspension of the procedural schedule, pending finalization of a stipulation and agreement in this case.
