On May 24, 2024, all parties to these files¹ jointly filed a motion requesting the Commission cancel the remainder of the procedural schedule, including the evidentiary hearing set for May 29-30, 2024. The parties indicate they have reached an agreement in principle that will resolve all issues in these cases.

The Commission finds the joint request of all parties to be reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. The request to cancel the remainder of the procedural schedule is granted.
2. The evidentiary hearing scheduled for May 29-30, 2024 is canceled.
