The Missouri Public Service Commission is correcting its *Order Granting Designation as an Eligible Telecommunications Carrier*, issued May 22, 2024, nunc pro tunc under 20 CSR 4240-2.160(4) to include granting Green Hills Telecommunications Services designation as an Eligible Telecommunications Carrier for purposes of receiving Missouri Lifeline and Disabled support, that was inadvertently not included in the Commission's order.

Body paragraph one where it states: "Green Hills Telecommunications Services requests ETC designation on a statewide basis for the purpose of receiving federal low-income support." is hereby corrected to read: "Green Hills Telecommunications Services requests ETC designation on a statewide basis for the purpose of receiving federal and state low-income and disabled support."

Body paragraph three where it states: "Staff recommended that the Commission approve Green Hill Telecommunications Services' request for designation as an eligible telecommunications carrier for the purpose of receiving federal low-income support on a statewide basis." is hereby corrected to read: "Staff recommended that the Commission

approve Green Hill Telecommunications Services' request for designation as an eligible telecommunications carrier for the purpose of receiving federal and state low-income and disabled support on a statewide basis.”

Ordered paragraph one where it states: “Green Hills Telecommunications Services is designated as an ETC for the purpose of receiving federal low-income support on a statewide basis.” is hereby corrected to read: “Green Hills Telecommunications Services is designated as an ETC for the purpose of receiving federal and state low-income and disabled support on a statewide basis.”

THE COMMISSION ORDERS THAT:

1. The *Order Granting Designation as an Eligible Telecommunications Carrier* issued May 22, 2024, is corrected nunc pro tunc as set forth in the body of this order.
