STAFF RECOMMENDATION TO APPROVE CHANGE OF SUPPLIER

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), by and through the undersigned counsel, and files this *Staff Report and Recommendation* to *Approve Change of Supplier* ("Report") with the Missouri Public Service Commission ("Commission"), and respectfully states as follows:

- 1. On November 30, 2016, The Empire District Electric Company ("Empire") and White River Valley Electric Cooperative ("White River") filed with the Commission their *Joint Application for Change of Electric Supplier* requesting that the Commission authorize a change of the supplier of electric service from White River to Empire for the structures situated on two parcels of property near the city limits of the City of Branson, Missouri, pursuant to 394.315.2, RSMo.
- 2. On December 2, 2016, the Commission issued its *Order Directing Notice* and *Order Directing Responses to Application* directing Staff to file a recommendation or a status report indicating when it will file its recommendation no later than December 22, 2016.
- 3. Sections 394.315 and 393.106, RSMo, give the Commission jurisdiction over rural electric cooperatives and investor-owned electric corporations, respectively,

to order a change to the supplier of electricity to a structure "on the basis that it is in the public interest for a reason other than a rate differential." Commission Rule 4 CSR 240-3.140 and 4 CSR 240-2.060(1) detail the filing requirements for applications for authority to change electrical suppliers.

- 4. Staff has conducted an investigation and reviewed the information submitted in this case file. Staff's *Memorandum* is attached hereto as Appendix A, and incorporated herein by reference. Staff, for the reasons stated therein, recommends the Commission approve the *Joint Application* as being in the public interest, for reasons other than a rate differential.
- 5. As Staff relates in its *Memorandum*, a developer has requested that White River's existing distribution line currently serving two structures near the developer's planned development be removed. Doing so requires a change of electric supplier to certain structures situated on two properties in the vicinity of the development. White River has consented to removal of the line, as the line is in need of substantial upgrades and the land on which the development is located is anticipated to be voluntarily annexed into the city limits of the City of Branson. Empire has agreed to serve the structures at issue, and the owners of the structures have consented to the proposed change of supplier. Therefore, Staff concludes that changing the supplier of electricity to the structures in question from White River to Empire would be in the public interest for a reason other than a rate differential.
- 6. Empire is current with its required filing of annual reports and its payment of assessment fees to the Commission. Staff is unaware of any pending or final unsatisfied judgments against Empire from any state or federal court involving customer

service or rates within three years of the date of filing this *Joint Application*. White River is not required to provide annual reports or assessments to the Commission

WHEREFORE, for the foregoing reasons discussed in detail in the Staff's *Memorandum*, Staff respectfully recommends the Commission issue an Order authorizing Empire to provide electric service to the structures located at 2229 Bird Rd, Branson, Missouri, 65616-9611, and 2115 Bird Rd, Lot 4, Branson, Missouri, 65616-9611, currently being served by White River, as requested in the joint application.

OVERVIEW

On November 30, 2016, The Empire District Electric Company ("Empire") and White River Valley Electric Cooperative ("White River") filed a Joint Application ("Application") with the Missouri Public Service Commission ("Commission") requesting a Change of Electric Supplier to certain structures in Taney County, Missouri, This Application involves electric service provided by White River to structures on two properties. The property addresses and the current members and property owners are as follows: (1) Robert Campa, 2229 Bird Rd, Branson, MO, 65616-9293, and (2) Patricia L Crawford, 2115 Bird Rd, Lot 4, Branson, MO, 65616-9611. Both addresses are in an area both utilities may serve, but White River currently provides electric service to the structures on the subject properties. Additional development is taking place in the area

and the developer requested that the White River line currently serving the structures on

the two subject properties be removed, as it is interfering with development plans. White

River does not object to removing this line, in order to aid development in the subject

area. White River serves the structures on the two subject properties within this

development area, while the remainder is served by Empire. Empire has distribution lines

currently in place readily capable of providing service to the structures on the subject

properties. The members identified above have consented to the proposed change of

suppliers from White River to Empire.

Empire is qualified to conduct business in Missouri, as well as in the states of

Kansas, Arkansas, and Oklahoma. Empire is engaged, generally, in the business of

generating, purchasing, transmitting, distributing and selling electric energy in portions of

said states. Empire also provides water service and natural gas distribution service in

Missouri. Empire's Missouri operations are subject to the jurisdiction of the Commission

as provided by law.

White River is a rural electric cooperative organized and existing pursuant to the

laws of the State of Missouri. It is a Chapter 394 rural electric cooperative corporation

engaged in the distribution of electric energy and service to its members within certain

Missouri counties. Rural electric cooperatives, such as White River, are subject to the

jurisdiction of the Commission as specified in Chapter 394 and Section 386.800, RSMo.

For the purpose of this case, White River is subject to the jurisdiction of the Commission

under 394.315.2, RSMo.¹

DISCUSSION

The Application between Empire and White River outlines their respective

service boundaries to the subject area. Empire holds a certificate of convenience and

necessity from this Commission to provide electric service to an area which includes the

subject properties; however the specific properties at issue are currently served by White

River. Empire provides electric service to neighboring properties in the area.

There are two distribution lines within the subject area that currently run in front

and in back of the subject properties; an Empire line and a White River line. Empire

provided Staff with a diagram identifying the White River line, which is attached to this

memo as Appendix A. Empire states that the existing infrastructure in front of the subject

properties requires no building or upgrades to serve the structures on the subject

properties. Empire anticipates that the structures that will be built on the subject

properties will not require it to install any new transformers.

White River estimates it will cost \$7,724.30 to remove its existing power line.

The line is approximately 1,300ft long, was built in 1969, and needs substantial upgrades.

It consists of 7 poles that are 35ft class 5, all of which need to be replaced with 40ft class

4 poles. According to White River, the developer intends to convert the use of the land

that White River's line crosses to residential; the area was formerly a mobile home park

and over the past several years the developer has removed manufactured houses in

preparation for building residential homes on the lots. The White River line is interfering

with these development plans, and the developer has requested that the line be removed.

interest for a reason other than a rate differential, and the commission is hereby given jurisdiction over rural electric cooperatives to accomplish the purpose of this section..."

In addition, this property is planned to be voluntarily annexed into the city limits of

Branson,² and once annexed White River will no longer be able to serve any new

structures near its line. Presently White River only serves the structures on two properties

in the subject area, and they are located on the opposite end of the subject area from their

take-off pole. Empire has power lines throughout the area; therefore, instead of spending

additional money to rebuild the power line to the existing structures, White River

believes, for safety reasons and to save money on the cost to rebuild the power line,

which would be in the best interest of all parties for Empire to serve the two properties.

STAFF RECOMMENDATION

Staff recommends that the Commission approve the Application to allow the

electric supplier to the structures on the subject properties in Taney County to be changed

from White River to Empire as being in public interest for a reason other than a rate

differential, as doing so will avoid unnecessary duplication of facilities, achieve

operational efficiencies, and support the further development of the area.

Staff is unaware of any pending actions or final unsatisfied judgments or

decisions against Empire by any state or federal agency or court that involves customer

service or rates, and Staff has verified that Empire filed its 2015 annual PSC reports and

is not delinquent on its PSC assessments.

To Staff's knowledge, White River has no pending or final judgments or

decisions against it from any state or federal agency or court which involve its members'
