ORDER SETTING DEADLINES FOR INTERVENTION APPLICATIONS AND STAFF RECOMMENDATION

On May 24, 2024, Summit Natural Gas of Missouri, Inc. (SNGMO) filed an application requesting an expansion and continuation of its Pilot Meter Sampling Testing Program. The expansion would apply to all meters with a rated capacity of up to 500 cubic feet per hour such that SNGMO's previously granted variance, which would otherwise end December 31, 2024, would expand and also be made permanent. The variance requested is from Commission Rule 20 CSR 4240-10.030(19), which outlines the requirements for periodic meter testing of utility meters.

The Commission will set a deadline for applications to intervene. The Commission will also direct the Staff of the Commission (Staff) to file a recommendation with regard to SNGMO's application.

THE COMMISSION ORDERS THAT:

1. Applications for intervention shall be filed no later than June 18, 2024. Any such filing shall be submitted through the Commission's electronic filing and information system or delivered to:

2. No later than July 10, 2024, the Commission's Staff shall file either a recommendation regarding SNGMO's application or a status report indicating when it expects to file a recommendation.

3. This order shall be effective when issued.
