## ORDER GRANTING APPLICATION TO INTERVENE

On September 25, 2017, Union Electric Company d/b/a Ameren Missouri filed its 2017 Integrated Resource Plan, as required by the Commission's Electric Utility Resource Planning Rule, 4 CSR 240-22. The Missouri Industrial Energy Consumers (MIEC) applied to intervene on October 2. More than ten days have passed since that application to intervene was filed and no one has responded to the application.

The Commission finds that allowing MIEC to intervene will serve the public interest. Therefore, in accordance with Commission Rule 4 CSR 240-2.075(3), the Commission will grant the application to intervene.

### THE COMMISSION ORDERS THAT:

1. The Application to Intervene of the Missouri Industrial Energy Consumers is granted.
2. This order shall be effective when issued.


