ORDER GRANTING VARIANCE

On April 1, 2024,¹ The Empire District Electric Company d/b/a Liberty, pursuant to

Commission Rule 20 CSR 4240-22.080(13),² filed an Application for Variance from a

portion of Commission Rule 20 CSR 4240-22.030 requiring electric utilities to use end-use

information in its analysis of its industrial class. Liberty requests the variance in regards

to the 2025 Integrated Resource Plan (IRP) triennial compliance filing it will be required

to make by April 1, 2025.

The Commission provided notice of Liberty's application to potentially interested parties and directed its Staff to file a recommendation regarding the application. The Commission also set a deadline for intervention and directed that any responses to the

Upon written application made at least twelve (12) months prior to a triennial compliance filing, and after notice and an opportunity for hearing, the commission may waive or grant a variance from a provision of 4 CSR 240-22.030–4 CSR 240-22.080 [effective August 28, 2019, 20 CSR 4240-22.030 through 20 CSR 4240-22.080] for good cause shown. The commission may grant an application for waiver or variance filed less than twelve (12) months prior to the triennial compliance filing upon a showing of good cause for the delay in filing the application for waiver or variance.

application be filed by May 16. Staff filed its recommendation on May 16. No applications to intervene nor responses to the application have been filed.

Commission Rule 20 CSR 4240-22.030(4)(A) requires that for each of a utility's major classes, use per unit shall be disaggregated, where information permits, by end-uses that contribute significantly to energy use or peak demand. Additionally, Commission Rule 20 CSR 4240-22.030(4)(A)(1) requires, generally, that utilities consider developing information on end-use load for the residential, commercial, and industrial classes.

Staff notes that, in Appendix A to its application, Liberty states that it plans to use the Statistically Adjusted End-Use (SAE) method for the Residential, Small Commercial, and Large Commercial classes. Liberty states that the SAE method is applicable to its Residential and Commercial classes because end-use data developed by the Energy Information Administration (EIA) and technology company Itron exist for these classes. However, Liberty notes that the EIA and Itron do not maintain end-use information for the industrial class. Likewise, Liberty does not maintain end-use data for the industrial class, and, accordingly, it requests a variance from Commission Rule 20 CSR 4240-22.030(4)(A)(1).

Staff further notes that, in its application, Liberty states that granting its variance request will not compromise the policy objectives of the resource planning process for electric utilities, will allow for a load forecasting methodology consistent with Liberty's last triennial IRP, will save time and expense in a time-consuming and detailed integrated resource planning endeavor, and, therefore, approval of its application is in the public interest. Staff agrees, and recommends approval of Liberty's request for a variance from

Commission Rule 20 CSR 4240-22.030(4)(A)(1).

Based on its review of the application and Staff's recommendation, Liberty has shown good cause for granting a variance from Commission Rule 20 CSR 4240-22.030(4)(A)(1) with regard to end-use data for the industrial class. Thus, the Commission will grant the variance requested by Liberty.

THE COMMISSION ORDERS THAT:

1. The Empire District Electric Company d/b/a Liberty's *Application for Variance* is granted. Liberty is granted a variance from Commission Rule 20 CSR 4240-22.030(4)(A)(1) with regard to the industrial class.

2. This order shall become effective on June 29, 2024.
