**ORDER SETTING A SCHEDULE FOR THE SUBMISSION OF A JOINT  
STATEMENT OF STIPULATED FACTS AND PARTY BRIEFS**

Issue Date: May 31, 2024

Effective Date: May 31, 2024

Union Electric Company d/b/a Ameren Missouri filed tariff sheets to extend its Charge-Ahead pilot program for two additional years. Those tariff sheets are currently suspended until July 26, 2024. Staff opposes continuing the pilot program and the parties were unable to agree on whether the program should be extended. On May 30, 2024, the Commission held a procedural conference to determine how the pilot program issue should be resolved.

There are not many factual disagreements between the parties. So, the parties agreed to resolve the Charge-Ahead pilot program issue through the submission of a joint statement of stipulated facts and two rounds of briefs. Therefore, the Commission will issue a schedule for the submission of a joint statement of stipulated facts and party briefs.

**THE COMMISSION ORDERS THAT:**

1. The parties shall file a joint statement of stipulated facts no later than June 14, 2024.
2. Initial briefs shall be filed no later than June 28, 2024.
3. Reply briefs shall be filed no later than July 9, 2024.

4. This order shall be effective when issued.
