## SPIRE MISSOURI'S REQUEST FOR ADDITIONAL TIME TO FILE AN ANSWER OR STATUS UPDATE

**COMES NOW** Spire Missouri Inc. ("Spire Missouri" or the "Company") and respectfully submits this *Request for Additional Time to File an Answer or Status Update* to the Missouri Public Service Commission ("Commission"), stating the following:

- 1. On March 25, 2024, Staff of the Missouri Public Service Commission ("Staff") filed a Formal Complaint as a follow-up to its investigation in Docket No. GS-2022-0047.
- 2. On March 28, 2024, the Commission directed Spire Missouri to file an answer to the Formal Complaint no later than April 29, 2024.
- 3. Staff provided recommendations in both its investigation report in Docket GS-2022-0047 and the recommendations included with this Formal Complaint. As noted in *Staff's Reply* in the investigation docket, filed February 1, 2024, Staff and Spire Missouri are in agreement on a number of the issues and recommendations. Staff also noted that further discussions or potential agreements on remaining issues would be better suited within this Formal Complaint docket.
- 4. On April 22, 2024, Spire Missouri filed a request for additional time to file its Answer or a status update. The Commission granted this request and ordered Spire Missouri to file an answer or a status update no later than June 3, 2024.
