On March 25, 2024,<sup>1</sup> the Staff of the Commission (Staff) filed a complaint against

Spire Missouri Inc. d/b/a Spire alleging violation of certain sections of the Commission's

gas safety rules. The Commission directed Spire to file an answer to the complaint.

On April 29, the Commission extended the time for Spire to file an answer to the complaint, or a status report, to June 3.

On May 31, Spire filed a Request for Additional Time to File an Answer or Status

*Update*, stating that additional time is needed to further develop a sampling program for the mechanical fittings that are the subject of the complaint. Staff does not object to Spire's request.

The Commission will grant Spire's request.
