1. On May 15, 2024, the Commission issued its *Order Approving Stipulation and Agreement and Establishing Ending ACA Balance* ("Order"), which ordered Spire to file a revised tariff that complied with the Order and the Full Unanimous Stipulation and Agreement.

2. On May 23, 2024, Spire filed a revised tariff sheet with an effective date of June 22, 2024, Tariff Tracking No. JG-2024-0159. Spire stated the revised tariff complied with the May 15, 2024 Order and incorporated the provisions of the *Full and Unanimous Stipulation and Agreement*.

3. On May 24, 2024, the Commission issued its *Order Directing Staff Recommendation on Revised Tariff Sheet* in which the Commission ordered Staff to file a recommendation no later than June 3, 2024, regarding Spire's revised tariff sheet.
