## ORDER APPROVING PURCHASED GAS ADJUSTMENT TARIFF

Issue Date: June 3, 2024

Effective Date: June 5, 2024

On May 21, 2024,<sup>1</sup> Spire Missouri Inc. d/b/a Spire filed a revised tariff sheet to reflect changes in the company's Purchased Gas Adjustment (PGA) rates for its western Missouri operating division (Spire West). The tariff sheet bears an effective date of June 5 and was assigned Tracking No. JG-2024-0158. The tariff sheet revision reflects a \$0.10 reduction in the Current PGA (CPGA) factor from \$0.75817 to \$.0.65817 per centum cubic feet (Ccf) for Spire West. The Actual Cost Adjustment (ACA) factor remains the same. In a cover letter filed with the revised tariff sheet, Spire states that "the decrease in Spire West is due to working off the balance of unrecovered gas costs. Spire East's charges will remain the same due to the remaining balance of unrecovered gas costs."

On May 22, the Commission ordered its Staff to file an expedited recommendation regarding the tariff sheet. Staff filed its recommendation on May 30. Staff recommends that the tariff sheet be approved on an interim basis, subject to refund, and pending final Commission decisions in ACA File Nos. GR-2023-0217 and GR-2023-0157. Staff cites Spire's Commission-approved PGA Clause allowing for ten business days' notice for PGA change filings as good cause for approval of the tariff sheet on less than 30 days' notice.

The Commission has reviewed the proposed revised tariff sheet and Staff's recommendation. The Commission finds that the tariff sheet conforms to Spire's Commission-approved PGA Clause and finds good cause to approve the tariff sheet on less than 30 days' notice. The Commission will approve the tariff sheet to become effective on June 5, on an interim basis, subject to refund.

**THE COMMISSION ORDERS THAT:**

1. The revised tariff sheet filed on May 21, 2024, by Spire, assigned Tracking No. JG-2024-0158, and bearing an effective date of June 5, 2024, is approved on an interim basis, subject to refund. The tariff sheet approved is:
