### ORDER DIRECTING STAFF TO FILE RECOMMENDATION AND SETTING DEADLINE FOR RESPONSES

Issue Date: June 3, 2024 Effective Date: June 3, 2024

On May 31, 2024, Missouri-American Water Company (MAWC) filed an application requesting authority to engage in a variety of secured debt financings with the Missouri Department of Natural Resources to be secured by placing a mortgage upon its property. In addition, MAWC requested waiver of the Commission's 60-day notice requirement.<sup>1</sup>

The Commission will direct its Staff to file a recommendation regarding MAWC's application. The Commission will also set a deadline for responses to Staff's recommendation.

#### THE COMMISSION ORDERS THAT:

- 1. No later than July 3, 2024, Staff shall file a recommendation regarding MAWC's application, or a request for additional time to file its recommendation.
- 2. Responses to Staff's recommendation shall be filed no later than July 11, 2024.
  - 3. This order shall be effective when issued.
