On April 15, 2024, Union Electric Company d/b/a Ameren Missouri filed its 2023 Renewable Energy Standard (RES) Compliance Report (Report) and its 2024-2026 Annual RES Standard Compliance Plan (Plan), as required by Commission Rule 20 CSR 4240-20.100(8). The Staff of the Commission filed its Staff Report on May 30, 2024.

Staff's Report states that Staff found several errors in Ameren Missouri's Report. Staff also has several concerns with Ameren Missouri's Plan. The Commission will order Ameren Missouri to respond.

### THE COMMISSION ORDERS THAT:

1. Ameren Missouri shall respond to the Staff Report no later than June 19, 2024.
2. This order shall be effective when issued.
