ORDER APPROVING COMPLIANCE TARIFF SHEET

On May 15, 2024, the Commission issued its *Order Approving Stipulation and Agreement and Establishing Ending ACA Balance* (Order). On May 23, 2024, Spire Missouri Inc. d/b/a Spire filed a revised tariff sheet, assigned Tracking No. JG-2024-0159, purporting to comply with the Order.

At the direction of the Commission, Staff reviewed the tariff sheet and determined that it complied with the Order, recommending that the Commission approve the tariff sheet. Based upon review of the tariff sheet and Staff's recommendation, the Commission finds Spire's revised tariff sheet complies with the Commission's Order and will approve it. To enable the tariff sheet to become effective on the date requested by Spire, the Commission finds it reasonable to make this order effective in less than 30 days.

THE COMMISSION ORDERS THAT:

1. The revised tariff sheet filed on May 24, 2024, and assigned Tracking No. JG-2024-0159 is approved to become effective June 22, 2024. The approved tariff sheet is as follows:
