The Empire District Electric Company d/b/a Liberty filed a Summary Report in this file on May 8, 2024. On May 15, 2024, the Commission received an intervention request from Renew Missouri. More than ten days have passed since the application was filed and no one has responded.

After considering the unopposed application to intervene, the Commission finds that the applicant has interests which are different from that of the general public and allowing the applicant to intervene will serve the public interest. Therefore, in accordance with Commission Rule 20 CSR 4240-2.075(3), the Commission will grant the application to intervene.

Before the Commission closes this file, the Commission will allow parties to state whether they believe the file needs to stay open.

### THE COMMISSION ORDERS THAT:

1. Renew Missouri's application to intervene is granted.
2. Any party who wishes to respond shall do so later than June 14, 2024.

3. This order shall be effective when issued.
