COMES NOW Co-Mo Electric Cooperative ("Co-Mo") by and through its undersigned counsel, and for its Response to the Application of Richard and Felicia Murphy ("Applicant") for Change of Electric Supplier, pursuant to the Missouri Public Service Commission's ("Commission") Order Directing Notice and Directing Responses to Application ("Order") issued on May 6, 2024 and, in support thereof, states as follows:

- 1. On April 9, 2024, Richard and Felicia Murphy (the "Customer" or "Applicant") filed an Application for Change of Electric Service Provider ("Application") with the Commission, requesting a change from Co-Mo Electric Cooperative, Inc. ("Co-Mo") to Union Electric Company d/b/a Ameren Missouri for 1915 Tisdale Dr, Boonville, MO 65233 (the "Property").
- Co-Mo takes no position on the sufficiency of the Application. Co-Mo
 requests the Commission deny Applicants' request as Co-Mo is able to serve
 the Property and it is within Co-Mo's service area as designated in a
 Territorial Agreement (Case No. EO-2022-0332).

new service and line extension design since April 6, 2024, and has been working with neighboring landowners to obtain an easement to be able to serve the Property.

- 4. If Ordered to serve this location by the Commission, Co-Mo is ready, willing and able to so serve. Pursuant to Co-Mo's policies that apply to all new services, some of the cost of construction will be required to be paid for by Applicant.
- Co-Mo is without knowledge to confirm or deny the remaining allegations of the Application.
