## ORDER DIRECTING FILING

On May 15, 2024, the Commission issued a Report and Order in File No. ET-2024-0182. That order stated, in pertinent part:

The Commission encourages Evergy, Staff, and any other party to bring a solution for all customers being able to access all TOU rates in Evergy's next rate cases and/or when Evergy expands the SSP. All participants should be able to have access to all TOU rates and Evergy should be moving forward and making progress in this regard. Since Evergy Missouri West has a general rate case pending in File No. ER-2024-0189, the Commission will make this a formal request in that case.<sup>1</sup>

In light of that Report and Order, the Commission will order Evergy, Staff, and any other party who wishes to comment, to make proposals in their next rounds of testimony that allow all residential customers the ability to utilize all TOU rates (including net metering and solar subscription program customers).

### THE COMMISSION ORDERS THAT:

1. The parties shall respond in their next rounds of testimony as ordered above.
