ORDER GRANTING EXTENSION OF TIME

On April 18, 2024,¹ Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed an application regarding the acquisition of the unregulated sewer assets of Barbara E. Rampone located in and around the Timber Ridge subdivision in Johnson County, MO (Timber Ridge). The Commission directed a recommendation or a status report from its Staff (Staff) no later than June 11. Staff timely filed a request for an extension of time to submit its recommendation.

Staff requested an extension until July 25 due to necessary review of data request responses and other data requests that are awaiting responses. Additionally, Staff stated it is in the process of reviewing the Missouri Department of Natural Resources compliance and enforcement documents concerning Timber Ridge, and has identified questions regarding the service area maps for the system.

Staff stated it conferred with Confluence Rivers, which has no objection to the extension request. The Commission will grant the unopposed request for extension.

1. Staff's request for an extension of time is granted. Staff shall submit its recommendation or a further status report no later than July 25, 2024.
