ORDER ESTABLISHING TIME TO RESPOND

On June 5, 2024, EAG Gulf Coast, LLC, on behalf of its client, West IP Communications, Inc. (West), notified the Commission that West no longer wished to be registered to provide Interconnected Voice over Internet Protocol (IVoIP) service in the State of Missouri. The Commission granted West's registration in File No. DA-2012-0412. The Commission recognized the change of name of West to Intrado IP Communications, Inc. (Intrado) in File No. DN-2020-0131.

The Commission has the authority to cancel a registration pursuant to Section 392.410.5, RSMo (2016), which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. Therefore, if no request for a hearing or objection to the request is received, the Commission may cancel the registration based on Intrado's request.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to file a motion for hearing regarding the cancellation of the Company's IVoIP registration.
