RESPONSE TO COMMISSION ORDER OF JUNE 7, 2024

COMES NOW Staff of the Missouri Public Service Commission and hereby files the following response to the Commission's *Order Directing Response* ("Order") dated June 7, 2024:

1. Based on the assumptions reflected in the Order, the total amount¹ to be securitized² if the Rush Island plant is retired September 1, 2024 is \$470,172,657, and the total amount to be securitized if the Rush Island plant is retired October 15, 2024 is \$467,644,988.

2. Based on the assumptions reflected in the Order, the total amount of Rush Island energy transition costs if the Rush Island plant is retired September 1, 2024 is \$463,935,800, and the total amount of Rush Island energy transition costs if the Rush Island plant is retired October 15, 2024 is \$461,418,810.

3. Based on the assumptions reflected in the Order, the total amount of Rush Island upfront financing costs if the Rush Island plant is retired September 1, 2024

¹ Upfront costs are based on estimates received from Ameren and are to be reviewed by the Finance Team through the pre-issuance review process and Commission review through the IAL process. Certain amounts are illustrated on the attached using an illustrative securitization cost of 5.59% as outlined in schedule KN-2 of the EF-2024-0021 Niehaus Testimony, which is calculated as of November 8, 2023. These items will be adjusted for the actual amounts or latest estimates on the date of issuance and reflect the terms of the issuance.

² Base mat coal inventory figure included is not rounded, as reflected on attached.

is \$6,236,857, and the total amount of Rush Island upfront financing costs if the Rush Island plant is retired October 15, 2024 is \$6,226,178.

4. Calculations of the foregoing amounts are reflected in the attachments hereto.

5. The Order directed Staff to work with the parties to develop this filing, but also ordered Staff to make this filing no later than June 12, 2024. Staff worked with Ameren Missouri in developing this filing but, due to time constraints and the press of business, was unable to include all other parties. Staff circulated the filing to the other parties, but given the filing deadline cannot say that all parties (including Ameren Missouri) agree with the calculations.

WHEREFORE, Staff respectfully requests the Commission accept this response and attachments in compliance with the Commission's *Order Directing Response* dated June 7, 2024.
