#### STAFF'S RESPONSE TO THE COMMISSION'S ORDER

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff"), by and through undersigned counsel, submits its *Response* to the Commission as follows:

1. On March 28, 2024, the Commission virtually hosted a pre-hearing conference with Staff, the Complainant, and the Respondent.

2. According to the Commission, on June 7, 2024, the Complainant requested a second pre-hearing conference in its ongoing complaint against the Respondent.<sup>1</sup> The Commission granted the Complainant's request on June 10, 2024, and directed parties to submit available dates by June 17, 2024, so that a second pre-hearing conference can be held before June 30, 2024.
