ORDER RECOGNIZING NAME CHANGE

AT&T Enterprises, Inc. submitted a letter dated April 1, 2024, advising that it was changing its name to AT&T Enterprise, LLC. Tracking No. JC-2024-0141 was approved and became effective May 2, 2024. The Commission's Staff filed recommendations indicating the company has complied with all statutory and regulatory requirements for changing its name. Staff recommends the Commission recognize the name change. The Commission will do so.

So that this order can be effective at the same time as the tariff sheets being approved, the Commission finds it reasonable to make this order effective in less than thirty days.

1. The Commission recognizes the name change of AT&T Enterprises, Inc. to AT&T Enterprises, LLC.
2. This order shall be effective on June 23, 2024.
