ORDER RECOGNIZING NAME CHANGE

Southwestern Bell Telephone Company d/b/a AT&T Missouri submitted a letter dated April 1, 2024, advising that it was changing its name to Southwestern Bell Telephone Company, LLC d/b/a AT&T Missouri (LLC). Tracking Nos. JI-2024-0137, JI-2024-0138, JI-2024-0139, JI-2024-0140, JI-2024-0142 were approved and became effective May 1, 2024. The Commission's Staff filed recommendations indicating the company has complied with all statutory and regulatory requirements for changing its name. Staff recommends the Commission recognize the name change. The Commission will do so.

The Commission finds it reasonable to make this order effective in less than thirty days.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes the name change of Southwestern Bell Telephone Company d/b/a AT&T Missouri to Southwestern Bell Telephone Company, LLC d/b/a AT&T Missouri (LLC).
2. This order shall be effective on June 23, 2024.
