On May 9, 2024, the Commission issued its *Order Setting Procedural Schedule*. The order set a Discovery Conference for June 17, 2024. The order also requires that any party that has a discovery concern file a brief statement describing that concern at least three business days before each discovery conference. If no party identifies any discovery concerns the presiding officer may cancel that conference.

No party has filed a statement identifying any discovery concerns and the scheduled discovery conference is less than two business days away. Thus, the discovery conference is canceled.

1. The June 17, 2024, discovery conference is canceled.
