On June 14, 2024, Union Electric Company d/b/a Ameren Missouri, the Staff of the Public Service Commission, the Office of Public Counsel, Natural Resources Defense Council, Midwest Energy Consumers Group, and Consumers Council of Missouri filed a Joint Motion to Amend Procedural Schedule (Motion).¹ The Motion requests the extension of two due dates and an expansion of the hearing schedule. The Commission will address only the extension of two due dates in this order.

The Motion states that the parties have determined they will need more time for discovery and to file the list of issues, order of witnesses, order of cross-examination and order of opening statements.

The Commission finds the requests reasonable and will grant them.

THE COMMISSION ORDERS THAT:

1. The Motion is granted in part.
2. The last day to issue Data Requests or other written discovery requests, subpoenas, or the last date by which a deposition may be taken shall be July 1, 2024.²

² The requested date of June 30, 2024 is a Sunday.

3. The List of Issues, List of Witnesses, and Order of Cross-Examination shall be filed no later than July 1, 2024.

4. This order shall be effective when issued.
