On June 14, 2024,<sup>1</sup> Union Electric Company d/b/a Ameren Missouri and Staff of the Commission (Staff) filed a Joint Motion for Extension of Time (Motion) requesting an extension to file a Joint Statement of Stipulated Facts.

The Motion explains that an agreement on the Joint Statement of Stipulated Facts has not been reached and an extension of time would allow discussions to continue. The Motion requested an extension to June 21.

The Commission finds the request for an extension to be reasonable and will grant it.
