On May 1, 2024, Missouri-American Water Company (MAWC) filed the above-referenced application. The application seeks authority for MAWC to acquire and operate the water and sewer systems of The City of DeKalb, Missouri. In addition to the application, MAWC filed a motion for waiver of the 60-day notice requirement under 20 CSR 4240-4.017(1)(D).

The Commission will direct notice of the application be given to the county commission and local media serving residents of the City of DeKalb, Missouri. The Commission will also direct notice of the application to the City of DeKalb and will further set a deadline for interested parties to intervene. Finally, the Commission will direct the Staff of the Commission to file a recommendation.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall provide a copy of this order to the City of DeKalb, Missouri.
2. The Commission's Public Policy and Outreach Division shall make notice of this order available to the media serving the City of DeKalb, Missouri.

3. Any person wishing to intervene in this matter shall file an application to intervene no later than July 9, 2024. The application shall be filed in the Commission's Electronic Filing and Information System (EFIS) or with the Secretary of the Commission. Comments on the application can also be made in EFIS.

4. Staff shall file a recommendation or a status report, stating when it expects to file its recommendation, no later than July 15, 2024.

5. This order shall be effective when issued.
