# ORDER GRANTING APPLICATION TO INTERVENE

Issue Date: June 18, 2024 Effective Date: June 18, 2024

On May 24, 2024, Union Electric Company d/b/a Ameren Missouri filed an application requesting a certificate of convenience and necessity.

The Commission directed notice and set a deadline of June 13, 2024, for applications to intervene. On June 7, 2024, the Consumers Council of Missouri (CCM) filed an application to intervene. Ten days have passed and no parties have filed an objection to CCM's application to intervene.<sup>1</sup>

After considering the unopposed application to intervene, the Commission finds that CCM has interests which are different from that of the general public and allowing CCM to intervene will serve the public interest. Therefore, in accordance with Commission Rule 20 CSR 4240-2.075(3), the Commission will grant the application to intervene.

## THE COMMISSION ORDERS THAT:

- The application to intervene of the Consumers Council of Missouri is granted.
