STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its recommendation respectfully states:

1. In the attached Memorandum, which is labeled Appendix A, the Staff recommends that the Missouri Public Service Commission recognize Matrix Telecom, Inc.'s (Applicant) fictitious name of Matrix Business Technologies.
2. Pursuant to 4 CSR 240-2.060(5), Applicant's request for name change clearly sets out both the old and new name to be used. In addition, Applicant has furnished a copy of the Registration of Fictitious Name that is on file with the Secretary of State.
3. In conjunction with the name change, Applicant has submitted Mo. PSC No.5, which reflects its fictitious name and replaces Applicant's previously filed Mo. PSC Tariff No. 4 in its entirety.
4. Applicant intends to send notice of the company's name change and new tariff to its customers as required by 4 CSR 240-3.545(20).

WHEREFORE, Staff recommends that the Commission issue and order recognizing the fictitious name, approving the new tariff, and canceling the old tariff. Staff recommends that the Commission order Applicant to send notice to its customers as required by 4 CSR 240-3.545(20).
