On December 12, 2016, Chariton Valley Telecom Corporation filed a letter informing the Commission that it is changing the name by which it provides telecommunications service in Missouri to Chariton Valley Communications Corporation, effective December 31, 2016. The company also filed tariff revisions purporting to incorporate that name change. The Commission will direct its Staff to file a recommendation regarding that notice.

1. The Staff of the Missouri Public Service Commission shall file a recommendation regarding Chariton Valley Telecom Corporation's notice no later than December 27, 2016.
