## ORDER APPROVING TARIFFS

On August 25, 2023, Confluence Rivers Utility Operating Company, Inc. (Confluence) filed the above-referenced application. The Commission approved the application on March 27, 2024. In the order approving the application, the Commission ordered Confluence to file tariffs.

Confluence filed tariffs with Tracking Nos. JW-2024-0161 and JS-2024-0162 on May 30, 2024. The tariffs bear an effective date of June 30, 2024. The Commission's Staff filed a Recommendation on June 20, 2024. The Recommendation stated that the Commission should approve the tariffs. No other responses were received.

The Commission finds that the tariffs comply with the Commission's March 27, 2024 order. The Commission will approve the tariffs.

### THE COMMISSION ORDERS THAT:

1. The tariffs filed by Confluence on May 30, 2024, and assigned Tracking No. JW-2024-0161 and JS-2024-0162, are approved to become effective on June 30, 2024.
2. This order shall be effective June 30, 2024.
